Lodging Reservations

Reservations for lodging will have to be made directly to Deer Creek Conference Center by calling 1-800-282-7275. (Please let the reservation personnel know that you are with the CMI User Group reservation: CMIBLOCK). In attempts to better utilize the available room space at Deer Creek, so more participants can join us, we are ask that you let the reservation clerk know how many will be in your group. There are several rooms that are capable of accommodating 4 or more persons. Cottages are also available upon request for large groups. Your assistance will be greatly appreciated, as this has been a major concern in past conferences.

Room reservations must be made prior to September 1 in order to take advantage of the special group rates offered by Deer Creek. These rates are \$115/per room and \$160/per cabin. Discounted rates are also available for Saturday and Tuesday nights, if you wish to arrive early or stay late. Please inquire about these rates with the Deer Creek reservations desk.
